Objectives:

Admission of students is fundamental to institute's sustainability. The policy provides guidelines to prospective students and those involve in admission process so that the admission process can be completed in a transparent way following the government guidelines.

Scope:

Admission of students to various programmes in Dhanalakshmi Srinivasan College of Engineering and Technology is purely based on merit following the rules and regulations of Tamil Nadu Government. The admission eligibility to various programmes is mentioned in the prospectus. The Government of Tamil Nadu selects 50 % of students through centralised counselling conducted by Anna University. The remaining 50 % of seats are filled by the college.

Admission Procedure:

The admission to the various programmes is based on merit without discrimination of caste and religion.

UG ADMISSION:

The UG admission is made based on: Government quota and Management quota. The government quota admission of 65% of sanctioned strength is made by single window counselling conducted by Anna University, Chennai on behalf of state Government. For Management quota admission of 35% of sanctioned strength, the state government has formed a committee for regulating admission in all engineering colleges in Tamil Nadu.

This regulation committee authorizes the association of engineering colleges to fill the management seats of all engineering colleges.

The interested applicant should get application form from this association and send the filled application to college of their choice.

The association prepares the rank list and accordingly issues allotment order to the candidate based on the choice of the college. The management quota admission is done based on the allotment order issued by the management association.

Qualifying Examinations and Eligibility for UG:

A pass in the HSC (Academic: both +1 and +2) or its equivalent with a minimum average percentage as given below.

PG ADMISSION:

The PG admission is made based on: Government quota and Management quotaequally shared 50%. The Government quota admission is made through single window counselling conducted by Anna University, Chennai, on behalf of state Government through TANCA (Tamil Nadu Common Admission). The Management quota admission is based on the entrance exam conducted by the Association of Engineering Colleges.

ME / MTech.

Based on the entrance (TANCET / CET / GATE) marks conducted by the Anna University & Consortium of Self Financing Professional, Arts and Science Colleges in Tamil Nadu.

Master of Business Administration (MBA)

Based on the entrance (MAT / TANCET / CET) marks conducted by the Anna University & Consortium of Self Financing Professional, Arts and Science Colleges in Tamil Nadu.

Master of Computer Applications (MCA) Degree

Based on the entrance (TANCET / CET) marks conducted by the anna University & Consortium of Self Financing Professional, Arts and Science Colleges in Tamil Nadu.

B.E. / B.Tech. (Lateral) - Three Years Programme

The candidates should have passed the Diploma in Engineering / Technology as awarded by the State Board of Technical Education, Tamil Nadu or its equivalent are eligible to apply for admission to the third semester of B.E. / B.Tech. in the branch corresponding to the branch of study.

The candidates should have passed the Degree in Science (B.Sc.) (10+2+3 stream) with Mathematics as a subject at the B.Sc. level are eligible to apply for admission to the third semester of B.E. / B.Tech. Such candidates shall undergo two additional Engineering subject(s) in the third and fourth semesters or fourth and six semesters respectively as prescribed by the respective Faculty.
